
## ASSP/AIHA Participated in Youth Outreach for DTEC

President Diana Stegall, CSP, CFPS, ARM, SMS, CPCU, is senior loss control consultant for United Heartland in Minnesota. A member since 1990, she was the first woman named ASSP's Safety Professional of the Year in 2005. Stegall is a two-time recipient of the Culbertson Outstanding Volunteer Service



Award. She has been a member of ASSP's Government Affairs Committee and chair of the Professional Development Conference Planning Committee. Stegall holds a bachelor's degree in chemistry from Wake Forest University.

President-Elect Deborah R. Roy, MPH, CSP, RN, COHN-S, CET, FAAOHN, is corporate director of health, safety and wellness at L.L.Bean in Maine. #### **New Active Shooter Resources**

Active shooter incidents are a growing problem in the U.S. and every workplace is vulnerable. No job is without risk.

Having a comprehensive plan in place can help your organization minimize the damage caused by an active shooter or armed assailant and save the lives of your employees. ASSP's technical report, "How to Develop and Implement an Active Shooter/Armed Assailant Plan," provides guidance on how safety professionals can work with businesses in advance of these types of incidents and develop a higher level of preparedness against workplace violence.

The five-part video series guides you through specific steps and strategies outlined in our technical report, including:

- Determining your risks and vulnerabilities
- Instituting "hard" and "soft" controls at your site
- Developing training and drills for your employees
- Planning for post-incident response and business continuity
- Conducting periodic plan audits

### **OSHA Updates**

OSHA has issued a final rule that revises 14 provisions in the recordkeeping, general industry, maritime, and construction standards that may be confusing, outdated, or unnecessary. The revisions are expected to increase understanding and compliance with the provisions, improve employee safety and health, and save employers an estimated \$6.1 million per year.

The revisions include an update to the consensus standard incorporated by reference for signs and devices used to protect workers near automobile traffic, a revision to the requirements for roll-over protective structures to comply with current consensus standards, updates for storage of digital x-rays, and the method of calling emergency services to allow for use of current technology. OSHA is also revising two standards to align with current medical practice: a reduction to the number of necessary employee x-rays and updates to requirements for pulmonary function testing. To protect employee privacy and prevent identity fraud, OSHA has removed the requirements that employers include an employee's social security number on exposure monitoring, medical surveillance, and other records.

## **Landscaping Safety Resources**
