#### Check for Takata airbag recall

There are over 40 million vehicles in the U.S. under recall due to a defective Takata airbag. The National Highway Traffic Safety Administration (NHTSA) estimates that there will be 65-70 million vehicles under recall by December 2019. As these vehicles span 19 manufacturers, Takata airbags may be in some of your personal or fleet vehicles. The airbags, which have the potential to explode and eject sharp metal fragments if the vehicle is involved in a crash, have caused serious injury and death. This defect is associated with long-term exposure to high heat and humidity.

#### What can you do?

First, you should search vehicle identification numbers (VINs) to see if they are under recall: <a href="https://vinrcl.safercar.gov/vin/">https://vinrcl.safercar.gov/vin/</a>. If so, contact your local vehicle dealer to get the vehicle repaired for free. #### OSHA fines Idaho Dollar Tree stores

OSHA cited Dollar Tree Stores at four Idaho locations for exposing employees to unsafe storage of merchandise, and blocked walkways and exit routes. The company faces \$898,682 in proposed penalties.

OSHA inspectors initially responded to a complaint alleging unstable stacks and piles of boxes in a Boise store's stockroom. Then they received another complaint alleging similar conditions in Caldwell, Nampa and Meridian.

At the four stores, inspectors found boxes stacked improperly, and blocked aisles and exit routes. In one store, inspectors found an employee who suffered injury from falling boxes. While an inspector shot video of conditions during another inspection, a stack of boxes fell and nearly injured an employee. During their investigation, inspectors learned that falling boxes had injured other employees. OSHA cited Dollar Tree for violations related to blocked aisles and exit routes, unsafe storage and stacking of boxes, blocked electrical panels, improper use of a ladder, and exposing workers to falls from heights. # New NIOSH Virtual Tool Kit helps responders work safely around drugs

NIOSH has released a virtual tool kit for First Responders on how to protect themselves from exposure to illicit drugs. The tool kit includes short training videos and sharable infographics that cover protection when illicit drugs may be present and when they are present, what PPE to wear, and how to decontaminate themselves and their equipment. Other resources based on key points from NIOSH recommendations are also included in the virtual took kit.

# EPA updates hazardous waste management guide

EPA has updated "Managing Hazardous Waste: A Guide for

Small Businesses." It provides an overview of the federal hazardous waste regulations to give business owners and operators a basic understanding of their hazardous waste management responsibilities. It answers questions like "Do hazardous waste regulations apply to me?" "How do I know which generator category I am?" and "What kinds of requirements do I have to follow?"



The Guide has been updated to reflect the changes to the regulations for hazardous waste generators since the previous version of the publication, including the 2016 Generator Improvements Rule, wastes added to the universal waste program, Subpart K for academic laboratories, the Hazardous Waste Pharmaceuticals Rule, and electronic reporting/e-manifest.

### New NIOSH webpage addresses suicide

NIOSH recently published a webpage on Suicide and Occupation. This page identifies information we know about the suicide problem, factors that are linked to increased risk of suicide among occupations, ways to



prevent suicide in the workplace, and a host of other resources.

### OSHA changes new beryllium standards

OSHA has issued a <u>final rule</u> on its beryllium standards for construction and shipyards that extends the compliance dates for ancillary provisions to Sept. 30, 2020. This extension accounts for OSHA's proposal to revise or remove those previsions and maintains enforcement of the lower permissible exposure limits (PEL).

OSHA says it will issue a proposed rule to amend the beryllium standards for construction and shipyards to more closely align the standards to the general industry standard where appropriate and tailor the mandates to the exposures in construction and shipyards. It will also work to clarify requirements with respect to materials that contain trace amounts of beryllium.

# OSHA issues new respirator fit testing protocols

OSHA issued a <u>final rule</u> that provides employers with two new fit testing protocols for ensuring that respirators fit properly.



The new protocols are the modified ambient aerosol condensation nuclei counter (CNC) quantitative fit testing protocol for full-facepiece and half-mask elastomeric respirators, and the modified ambient aerosol CNC quantitative fit testing protocol for filtering facepiece respirators. Both protocols are abbreviated variations of the original OSHA approved ambient aerosol CNC quantitative fit testing protocol (PortaCount®), but differ from the test by the exercise sets, exercise duration, and sampling sequence. These protocols will serve as alternatives to the four existing quantitative fit testing protocols already listed in appendix A of the Respiratory Protection Standard and will maintain safety and health protections for workers while providing additional flexibility and reducing compliance burdens.
